- 1. Photos must be public not private in order for us to judge them
- 2. The title of the P1 Marine Foundation Photographic Competition 2014 is "Autumn Coast". The theme is open to individual interpretation but entries must reflect the UK marine environment in autumn. P1 Marine Foundation's decision as to the eligibility of individual photographs will be final and no correspondence will be entered into.
- 3. Instagram is a free application ("app") that can be downloaded to any smartphone or device that will run the app. You will be required to set up an Instagram account, if you don't already have one, and follow Instagram's terms of use in order to share your Submission and enter this Contest.
- 4. Entrants can submit as many photos as possible. All images must be submitted via Instagram by being tagged with #P1AutumnCoast.
- 5. P1 Marine Foundation is aware that digital photography does allow for some image enhancement. You can enter images that have had spots, scratches or other blemishes removed. You can have worked on the colour or enhance the image for the sake of composition. You can also crop the image to improve composition.
- 6. We will not accept composite images or entries that superimpose elements photographed separately onto an image. P1 Marine Foundation and the judges reserve the right to exclude any image they believe may have been excessively treated so as to alter its authenticity.
- 7. The competition is open to UK residents only (including residents of the Channel Islands and Isle of Man). Employees of P1 Marine Foundation, as well as their immediate families or anyone else associated with this competition, are not eligible to enter. Entrants under the age of 16 years need to have parent or guardian consent to enter.
- 8. Entrants must not be professional photographers.
- 9. The competition closes at midnight on 1st November 2015. Entries received after this date will not be considered. The winner will be notified within seven days of the closing date of the competition. Unsuccessful entrants will not be contacted and no feedback on any entry will be provided.
- 10. All photographs will be judged on the following criteria:
 - a. Theme
 - b. Creativity
 - c. Originality
- 11. The photographs will be judged by a panel comprised of (TBC). The judge's decision will be final and no correspondence can be entered into.
